Substituting early is best.

- d) A photocopy of the Registration Certificate will be given to the buyer.
- e) Copy of a health certificate, with animal highlighted.

- The seller is responsible for the care of their stock when they arrive at the grounds and during the sale.
- Sellers must be available to speak with the auctioneer and potential customers.
- 1 bag of shavings is provided for each lot. If additional bags are needed, please pre-order and pay at pick up. **No hay or straw for bedding, shavings only.**
- **Tack Pens are not provided.** If you would like a pen to store feed and supplies, please indicate how many additional pens are needed and include \$10. for each additional pen. Feed and supplies may be stored in your trailer. There is a designated parking area nearby. The Isles must remain clear.
- Water is available in the barn. Please provide your own buckets and feed pans for stock.
- Goats must be removed from the facility by 10 pm May 31st, or by 8am, Sunday June 1, 2025. Midwest Buck Sale LLC and its representatives are not responsible for stock left overnight, after the sale. Any goats remaining on the grounds after 11 am June 1, will become the property of the Midwest Buck Sale, LLC.
- All funds from the sale are deposited into a custodial account, managed by Midwest Buck Sale, LLC. Payments to sellers for stock sold should be received within 7-10 business days. An email will be sent when funds have been mailed. We are not responsible for lost or misdirected mail. Please notify us if you do not receive the check within 7 business days after notification of mailing. Please deposit funds as soon as you receive them.

CONSIGNED STOCK REQUIREMENTS:

Ages: All Goats must be born before February 1, 2025, to be entered as an individual lot. Stock younger must have adult doe that kidded the offspring (recip or natural parent), included.

Buck Limit: Limit of two bucks per Farm/Ranch. One buck for every three does entered. Please email with any questions.

DNA: Please provide all DNA information with certificates in your packet. Animals are not required to be DNA'd for the sale.

Confirmed Bred Does: Must be verified pregnant via sonogram or blood test with documentation available at check-in, within 30 days of June 1, 2025.

Does may be advertised as “exposed” if not confirmed pregnant.

Goat Inspection

ALL STOCK IS INSPECTED FOR QUALITY. CULLS WILL NOT SELL.

Please select your top quality and stock in the best of health.

Upon arrival, all goat stock will be visually inspected for general health and condition. If an animal shows signs of sickness, you will not be allowed to unload that animal, nor will that animal be allowed to sell.

Goats with any of the following will be excluded in the sale:

- Suspicious knots and scars. If a knot appears before the sale time, that goat will be removed from the facility and will not be sold. If a knot is detected in the sale ring, that sale will be voided. All goats with obvious injection sites and knots will be determined by sale management on a case-by-case basis.
- Teats must be functional. One or two teats on each udder. Teats must be acceptable by the breed standard of each goat. Cluster teats, spurs, fish teats, non-functioning, mastitis, or obvious clipping of teats are not allowed, and animal will not sell.
- Pinkeye
- Sore Mouth
- Misshapen hooves or other foot issues, including any type of infection or any other defect.
- A split in the scrotum of more than 1 inch, one testicle or twisted testicles.
- All goat stock must be reproductive and meet the general standard of production stock. **CULLS WILL NOT SELL. NO REFUNDS**
