- ✓ Copy of the interstate health certificate with highlighted matches to registration documents
- ✓ Transfer form (leave buyer info blank)

### • Quality Standards:

All stock will be visually inspected upon arrival. Animals with the following will not be allowed to unload or sell:

- Visible illness or poor condition
- Suspicious knots, scars, or injection sites
- o Pinkeye, sore mouth, or hoof defects
- o Split scrotum (over 1 inch), twisted testicles, or one testicle

- o All goats must be born before February 1, 2025
- o Bred does must have documentation of pregnancy within 30 days of the sale
- o If entering more than one buck, please be sure they are quality and in good condition
